



STALL APPLICATIONS CLOSE ON THE 1ST July 2018. ALL PAYMENTS ARE TO BE RECEIVED BY THIS DATE.

Stall Holder's Terms & Conditions

1. Location:

For 2018 the festival will be on the Clem Thompson Oval. The final site plan will be distributed as soon as it is finalized.

2. Timing & Trading Hours:

Stall must be ready on site to begin trading by 3pm Friday 10th August and be closed by midnight Saturday 11th August 2018. Stall holders may not enter onto the oval before 10am Thursday 9th August and must clear the site by 5pm Sunday 12th August.

No trading is permitted before 3pm Friday 10th August. If stall holders wish to trade after midnight Saturday 11th August then they must leave the Clem Thompson Oval and have obtained a Trading Permit from the Shire of Ashburton.

3. Vehicles:

Safety requirements limit vehicle movement on the oval. Please be prompt with your arrival and also be patient whilst large stall holders are placed on site as a priority. The oval will be clearly marked indicating the oval's reticulation locations which must be avoided whilst driving on the oval. Please refrain from locking the front wheels on your vehicle as this will damage the oval's surface and create ruts in the grass. Repair costs due to damage to the oval's surface will be invoiced to stall holders that do not follow these rules.

4. Sand bags:

A number of sand bags will be placed around the oval for stall holders to use. Due to swirling high winds that may occur during this time of year we recommend investing in appropriate weights for gazebos and any other equipment that is at risk of becoming displaced in the event of high winds.

5. Grey Water Disposal:

There is ZERO TOLERANCE on dumping, discarding or flushing of waste material onto the oval surface. This includes, but not limited to grey water, oils of any type, greases, washing water, soapy waters, all vehicle fluids. Anyone doing this will be fined for the clean-up and will not be permitted to attend future Nameless Festivals. If you are camping on site you are required to have a catchment vessel for all of your waste water. If your vehicle/s are parked on the oval you must have an oil tray underneath your vehicle if it is at risk of leaking oils.

6. Rubbish:

It is your responsibility to dispose of ALL rubbish. Large green bins will be placed around the oval for stall holders to use only. Please compact your rubbish before placing it in the bins to maximise storage. The yellow bins are for our patrons only and not to be used by stall holders.

7. Exiting Your Site:

Before leaving your site

you must be signed off by a committee member to check the condition of your site. Please make sure you have followed the terms and conditions for Vehicles, Grey Water Disposal and Rubbish as you may be liable for cost of damage to the oval.

8. Insurance:

The Nameless Jarndunmunha Festival (NJF) accepts no responsibility for accidents or incidents that may occur on the stall holders allotted stall space. The Festival is not responsible for any damage, loss, theft or personal injury. A security guard will monitor the oval from midnight to 6am Friday & Saturday nights. All stall holders MUST hold a current Public Liability Insurance policy for not less than \$10m. Stall holders may not enter their site until they have given a copy of their current insurance to the Stalls Coordinator.

9. Fire:

Stall holders must have their own fire extinguishers and/or fire blankets. UNDER NO CIRCUMSTANCES can any stall holder have a camp fire, bon fire or any of the sort on or near the oval. Failing to comply with this may result in eviction from the festival grounds.

10. Amusement Rides:

All rides must comply with AS3533.2 and carry the appropriate levels of insurance.

11. Food:

All food stall holders must ensure compliance with the Shire of Ashburton health regulations and bylaws.

12. Liquor:

No liquor is to be sold or consumed in an unlicensed area or unlicensed stall.

13. Show bags:

All show bag must comply with the Ministry of Fair Trading 'Product Safety and Trade Measurement Requirements for Show Bags'.

14. Prohibitions:

The items, goods, articles, publications or materials on the following list are prohibited. If the NJF, at its sole discretion, considers anything, which falls within this list, is exhibited, sold distributed, used or offered as a prize by a stall holder, that stall holder must, after a request from the NJF to do so, immediately remove all of that type from the festival.

- Gas filled balloons unless the balloon is fitted with a non-conductive and rigid rod or straw
- Bows or arrows of any description
- Food skewer sticks with sharp ends
- Cap guns, caps for guns or other similar equipment
- Guns or guns which can be converted to fire dangerous missiles or replica pistols or starting pistols
- Chemical sprays, silly string, stage door streamers or other similar spray projecting materials, pepper sprays, fireworks including sparklers
- Anything illegal
- Anything offensive
- Anything which may by its use or operation cause alarm or distress to any person or animal
- Smoking implements r paraphernalia, bongos or drugs 'R' or 'X' rated videos, tapes, CD's or cassettes
- Anything referring to alcohol abuse, drug use, violence or that are sexually explicit or suggestive in nature

15. Dogs:

Stall holders are discouraged from bringing their dogs. As per the Shire of Ashburton regulations, dogs must be on a leash at all times and droppings must be cleaned up. Any dogs that are roaming free will be picked up by the Shire Ranger and taken to the pound.

16. Resolution of differences:

The Stalls Coordinator & Site Services Coordinator has the final word on any disputes, particularly about site allocation. It is expected that all parties will be courteous and respectful in the process of discussing issues.

17. Breach of Term & Conditions:

If any stall holder breaks any of these terms and conditions, they may, at the sole discretion of the Festival Committee, be required to leave the oval straight away, and/or may not be invited to attend subsequent festivals.

NOTE: STALL HOLDERS ARE REQUIRED TO PROVIDE A COPY OF THEIR CURRENT INSURANCE CERTIFICATE. FOOD STALL HOLDERS MUST ALSO PROVIDE A COPY OF THEIR FOOD BUSINESS REGISTRATION AND YOUR FOOD SAFETY CERTIFICATE. NO TRADING WILL BE ALLOWED UNTIL THE STALLS COORDINATOR HAS COPIES OF THESE DOCUMENTS.

Please consider all of your equipment that you will be bringing on site ie. vehicles, trailers, gazebos and your stall frontage. **ONCE YOUR SITE IS BOOKED IT CANNOT BE CHANGED. PLEASE DOUBLE CHECK YOUR MEASUREMENTS BEFORE SUBMITTING YOUR APPLICATION.**
